COLL OF MIDT OF HOGH DOMES

I Hugh Jones of the Township of Marmora, in the County of Hastings and Province of Ontario, Yeoman, being of sound and disposing mind and memory do make and publish this my last Will and Testament hereby revoking all former Wills by me at any time heretofore made.

I hereby constitute and appoint Soloman Johns, of the Township of Marmora, in the County of Hastings and Province of Ontario, Yeoman, and Robert Downs of the Village of Stirling, in the County and Province aforesaid, Lumberman, Executors of this my last Will directing my said Executors to pay all my just debts, funeral and testamentory expenses and to erect a Tombstone over my grave within one year after my decease, and to pay the legacies hereinafter given out of my Estate.

I give and bequeath to my beloved wife Ann Jones, all my household furniture, one cow and a sufficient quantity of hay and pasture for the support of Same, also wood my said wife may require for her own use as fuel whilst she may remain my widow which said, Hay, Pasture and Wood are to be furnished by my son Robert or his heirs. I further Bequeath to my said wife the use of the Dwelling in which I now reside (reserving the kitchen and half of the celler for my son Robert's use) for and during the time she may remain my widow. I further Bequeath to my said wife an annuity of One Hundred and Fifty Dollars, the same to be paid her yearly by sons Alexander, Hugh, Richard, Robert and William or their Heirs for and during her natural life in the proportion of Thirty Dollars from each. I give and devise to my beloved wife Ann Jones a House and Plot of ground in the Village of Stirling in the County of Hastings said House and Lot being on the East side of North Street and being the near part of Lot no. 6 on the North side of Mill street and marked number Five in diagram annexed reserving for the joint use of occupants of Parcels Nos.

side of Said Parcel no. Five to have and hold the same for her own absolute use and benefit forever.

I give and devise to my son Alexander Jones Parcel
No. one in annexed diagram upon which is erected a frame shop
now occupied by John Gallagher and being part of Lot. No. six
on the North side of Mill Street in the Village of Stirling
aforesaid, with the use of jointly with Occupants of Parcels
nos. 2,3,4, and 5, of a lane ten feet in width in rear of said
Parcels Nos. 1,2,3, and 4, I also give and devise to my son
Alexander Jones the North half of lot No. Fourteen in the sixth
concession of the Township of Marmora, in the County of Hastings
to have and to hold the same together with the aforesaid Parcel
No. one, for and during his natural life and at his decease to his
heirs forever, subject only to an Annual payment of Thirty Dollars
to my wife Ann Jones during her life.

no. Eight on the West side of McGill Street in the Village of Marmora in the said County upon which is erected a Stone Hotel. I also give and devise to my son Hugh Jones Village lots nos. six, seven and eight, on the South side of Wellington Street and village lots six, seven and eight on the north side of Albert Street - all in the Village of Stirling, in the County of Hastings to have and to hold the said devised parcels of land for and during his natural life and at his decease to his heirs forever, subject only to an Annual Payment of Thirty Dollars to my wife Ann Jones during her life.

Four in the Annexed diagram upon which is erected a stone store and Frame Store House and now occupied by Jas. Bolderick and being on the corner of Mill and North Streets in the said Village of Stirling with the use of jointly with occupants of Parcels nos. 1,2,3, and 5 of a lane ten feet in width in the rear of the Said Parcels, to have and to hold the same during the term of his natural life and at his decease to his heirs forever, subject only to an Annual Payment of Thirty Dollars to my wife Ann Jones during her life.

Building now occupied by one Berry and A.L. Anderson and being part of Lot no. Six on the North side of Mill Street in the Village of Stirling aforesaid with the use of jointly with occupants of Parcels Nos. 1,2,4, and 5, of a lane ten feet in width in the year of the Said Parcels. I also devise to my son William Jones the S.E. 1/4 of lot no. 14 in the 6th Concession of the Township of Marmora, also 17½ acres off the west end of the S.W. Eight of Lot 14 in the sixth Conc. of Marmora, also the N.W. 1/4 of lot 13 in the said 6th Conc. of Marmora also 2 acres off the S.E. corner of the S.W. 1/4 of lot 13 in the said 6th Conc. of Marmora in the aforesaid County of Hastings, and known as Stoney Field, to have and to hold the said devised lands during his natural life and at his decease to his heirs forever subject only to an Annual Payment of Thirty Dollars to my wife Ann Jones during her life.

I give and devise to my son Robert Jones Parcel No. Two in the annexed diagram upon which is erected a frame shop now occupied by R. Finch and being part of lot No. 6 on the North side of Mill Street in the Village of Stirling aforesaid with the use jointly with occupants of Parcels Nos. 1,3,4, and 5 of a lane ten feet in width in the rear of the said Parcels. I also devise to my son Robert Jones, the S.W. 1/4 of lot No. 13 in the 6th conc. of the Township of Marmora with the exception of 2 acres off the S.E. Corner of said parcel of land, given to my son William Jones, and known as the Stoney Field. lot 12 concession 6 also give to my son Robert the N. in the Township of Marmora, also 7½ acres off the east end of the S.W. Eight of lot 14 conc. 6 of Marmora and County of Hastings to have his natural life and at his decease to his heirs forever subject only the right of way for my son William or his heirs, until such time he or they may erect a barn, to and from a Spring on the West side of the Barn on the S.W. 1/4 of lot 13 conc. 6 of Marmora and a sufficiency of wood for fuel and Hay and Pasture for one cow for my said wife and also the interest of my said wife in and to the dwelling now occupied by me and an Annual Payment of Thirty Dollars to my said wife Ann Jones during her life.

I give and Bequeath to my daughter Annie Warren \$200.00 in money, the same to be paid her by my executors within three years after my decease.

I give and Bequeath to my daughter Sarah Barley \$200.00 in money, the same to be paid her by my exectors within three years after my decease.

I give and devise to my Grandson Hugh John Warren, son of Thomas and Ann Warren, Village lot no. 5 on the North side of Albert Street in the Village of Stirling in the County of Hastings to and for his own use and benefit forever.

I give and devise to my Grandson Hugh Boyd, son of Eyskiel and Mary Boyd, Village lot no. 5 on the South of Wellington Street in the Village of Stirling in the Said County of Hastings to and for his own use and benefit forever.

I give and devise to my Grandson Hugh Bailey son of James C. and Sarah Bailey, Village lot no. 4 on the South side of Wellington Street in the Village of Stirling and County of Hastings to and for his own use and benefit forever.

I give and devise to my Grandson Hugh Jones, son of Alexander and Margaret Jones, Village lot no. 4 on the North side of Wellington Street in the Village of Stirling and County of Hastings to and for his own use and benefit forever.

And for the payment of legacies of aforesaid I give and devise to my executors upon Trust all the rest and residue of my personal and Real Estate owned by me at my decease and I will and devise and direct my said executors as follows, that is to say, after Payment of the aforesaid legacies and after paying my just debts, funeral expenses and the necessary expenses incurred by my said executors in the due execution of this my last Will and Testament that the rest and Residue of my Estate whatsoever and wheresoever shall be devided equally among my sons Alex, Hugh,
