# HIGHWAY AY WORKER STRUCK BY CAR DIES IN HOSPITAL STANLEY JACKSON MARMORA, VICTIM OF ACCIDENT NEAR VILLAGE

# INQUEST WEDNESDAY

Stanley Jackson, 43 year old Marmora employee of the Department of Highways, died in Peterborough Hospital Saturday afternoon following injuries received when he was struck by a car said by police to be driven by Leo Cleary. Hastings, 7 miles east of Marmora Village on Highway No. 7.

An inquest looking into the circumstances surrounding the death of Jackson has been ordered held in Havelock on Wednesday by Coroner W.N. Young, Peterborough.

Jackson was given first aid treatment at the scene of the accident by Dr. H. Crawford, Marmora, and was rushed to hospital by ambulance where he died shortly after admission.

According to police Jackson was employed spreading loose gravel on that part of the highway, using a rake to level the piles as they were dumped by department trucks. In a statement given to Provincial Police Constable Arthur Dymond, investigating officer, Cleary said that the deceased had stepped back off the road, then back on again.

Nearing the man, Cleary, travelling east, noticed him suddenly step back in the road directly in the path of his car. He applied his brakes but not in time to avoid striking Jackson.

## Skid marks Visible

Skid marks for a distance of sixty-nine feet were visible on the highway west of the place where the accident occurred, Constable Dymond stated.

Jackson was knocked down by the force of the impact, rolled under the car and dragged for some distance before the car was stopped and he was extricated from beneath the vehicle. He showed little signs of external injuries when treated by Dr. Crawford at the roadside. Signs posted along the side of the highway at this point warn motorists to drive slowly, as loose gravel is being laid down. The signs are marked with a red flag.

Charges against Cleary were pending the outcome of the inquest being held on Wednesday. Jackson, who resided in Marmora, leaves a wife and a large family, and had been employed by the Department of Highways on that part of No. 7 Highway for some time.

## STANLEY JACKSON FATALLY INJURED

While working on No. 7 Highway, just east of what is known as No. 2 camp, last Saturday afternoon Stanley Jackson was struck and run over by an automobile, said to have been driven by Leo Cleary, of Hastings. Skid marks were visible for a distance of sixty-nine feet and Jackson was dragged for some distance under the car. After he was extricated he was given medical attention by Dr. Hamilton Crawford, who realized the injuries would prove fatal, and then rushed to St. Joseph's Hospital, Peterborough, where he died a few hours later. An inquest will be held in Havelock.

At the time of the accident Jack son was engaged with two or three others in spreading earth and calcium chloride on the road. H. E. Vansickle's truck was spreading clay on the road, with which

the calcium chloride was to be mixed, and Jackson was removing stones from it by gathering them with a shovel and throwing them to the side of the road.

Cleary, who was driving east, is alleged to have admitted seeing Jackson walking back and forth across the road a considerable distance ahead and also that he was driving 40 to 50 miles an hour. The skid marks would indicate that he was travelling quite fast. There were signs up warning motorists to drive slow as men were at work and there were red flags attached to the signs to emphasize the warning. In spite of that Cleary did not slow up much until just before the accident, when he applied the brakes, but it was too late.

The accident was investigated by Prov. Constable A. Dymond, of Madoc, and County Constable Percy Gray, of town.

## LEO CLEARY EXONERATED

On Monday afternoon Magistrate J. L. Lloyd presided at a session of the Police Court, when the charge of criminal negligence against Leo Cleary, in connection with the death of Stanley Jackson, was heard.

Crown Attorney B. C. Donnan appeared for the prosecution and Hon.G. N. .Gordon, K.C., of Peterborough, for the defence.

The first witness called was Miss Veronica McFadden, Reg. N., who was in the front seat of the Cleary car when the accident occurred.

She said that when they came round a curve in the road the deceased was working on the road. When he was about 300 yards away, as far as she could judge distance, Mr. Cleary blew his horn. Mr. Jackson started towards the south side of the road and then stopped and turned back towards the centre.

The driver turned his car towards the centre of the road to give plenty of room to pass, but Jackson started in one direction and then the other three or four times, facing towards the car nearly all the time.

When he was sighted the car was travelling about 40 to 45 miles an hour and after blowing the horn Mr. Cleary slowed down probably to 35 miles an hour. When near Jackson he applied the brakes and the car was nearly stopped when the accident occurred. When it struck the victim he fell towards the south and the right front wheel apparently passed over his chest.

The car only travelled about 3 or 4 feet after the impact. When they got out of the car the man was still breathing. A number of men soon arrived and a call was sent for the police and a doctor. The injured man was placed in the Cleary car and driven to his home at the western edge of Marmora. On the way they met Dr. Crawford, who turned and led the way to Jackson's residence.

Mr. and Mrs. Keegan, the other occupants of the car were next called and they fully corroborated the evidence of the first witness. Mr. Keegan said he had driven a car for years and having regard to all the circumstances he did not know of anything else that could have been done to avoid the accident.

H. Vansickle was the next witness. He told of seeing the car stop and the occupants get out hurriedly. He did not see the injured man at first and thought the car must be on fire. When told of the accident he hurried to the car and helped pull Jackson from under the car.

Questioned as to whether there was any indication of the driver or other occupants of the car being under the influence of liquor the witness said he did not see any indication of liquor or smell liquor on any of them.

Manley Lavender was next called and told of standing on the mark left by the back wheel of the car the Police arrived when measurements were taken. Asked whether he thought there was any thing else the accused might have done to avoid an accident the witness said it was hard to say what might be done unless one actually had to face the conditions.

Mr. Scott of Belleville produced three photos taken by him on Monday following the accident, when Prov. Constable Dymond and County Constable Danford, of Madoc, were present at the scene of the accident.

Dr. Hamilton Crawford gave evidence of having been called to the scene of the accident. He met the car conveying Jackson to his home and on examining him found his pulse good and did not think his condition so serious. Later on examining him at his home he found Jackson much worse. He was sent to a hospital in Peterborough but died shortly after being admitted. Mr. A. Dymond, Provincial Constable, gave detailed evidence as to the course of the car before the accident, the distance it travelled, 69 feet after the brakes were applied, etc. There was no indication that the body had been dragged along the road at all. He saw the accused at the home of Stanley Jackson and obtained a statement from on the right side of the Highway when the accident occurred. He had applied his brakes and turned out past the curb in an effort to avoid the *doctor*? (man?) who was about two thirds the distance across the street. Investigations were made by Traffic Officers Hatch, of Marmora, and Broughton, of Peterborough, and Constable Akins, of Havelock.

The injured man was attended by Dr. H. Crawford and Miss Grace Crawford, R. N.. of Marmora, after being removed to his home. His injuries although serious are not considered to be critical, there being no skull fracture. The *doctor*? (injured man?) never lost consciousness and last evening was reported to be resting quite well.

# MR AND MRS. GORDON JARVIS \*

MARMORA COUPLE INSTANTLY KILLED IN HIGHWAY MISHAP

Mr, and Mrs. Gordon Jarvis, a well known and highly respected Marmora man and wife, were instantly killed in a highway accident near Whitby on Tuesday Oct. 6. News of their sudden passing came as a saddening shock to their many friends in Marmora.

The accident occurred on a section of No. 401 Highway which was under repair and was using only one side of (the highway for two lane traffic.

An empty car transport proceeding easterly suddenly swerved to avoid a car which came off the Whitby cloverleaf without stopping. The driver applied his brakes and the trailer jackknifed on the wet pavement and slammed into the Jarvis car which was westbound. The car passed completely under the three foot space below the trailer and emerged amass of tangled wreckage. A car (following the Jarvis car struck the rear of the transport and the driver was slightly injured. Two other persons have been killed on the same piece of road within five days and apparently the section of road under construction was not too well marked.
