One of the largest Orange funerals that this town has ever seen was that of the late Arthur Smith which took place on Sunday afternoon. The deceased having been caretaker of the Orange Hall for eighteen years and residing there as well filling the office of Financial Secretary of the local lodge, was known to Orange Brethren over a wide area. The attendance of well over two hundred brethren and approximately forty sisters of the Lady Orange and True Blue Associations was a striking testimony to the popularity of the one so suddenly removed by death. So large was the assemblage at St. Paul's Church that brethren of the order, exclusive of officers of the L.O.L. 319 and a few visiting brethren, courteously consented to remain outside to permit other worshippers to participate in the service at 8.30 p.m. The church was filled to overflowing. The service was taken by the Rector, Bro. Rev. A. B. Caldwell while the lesson was read by the Rev. M. Levasen, rector of Rawdon. The hymns were "Jerusalem, my happy home, Our blest Redeemer" And "Rock of Ages." Mr. W. M. Lester beautifully rendered "Hold Thou my hand." The Rector's exhortation was based on Cor. 1-16, verses 18 and 14, "Watch Ye, stand fast In the faith, quit you like men. be strong. Let all your things be done with charity." From the church, the cortege weeded its way to the Protestant Cemetery via Madoc and Forsythe Streets and was seen to extend a greater length than that of the business section of the town. At the graveside, prayers of the Church were taken by the two officiating clergymen and last rites of the Order discharged in turn by Bros. W. J. Cottrell and Rev. A. B. Caldwell.

ARTHUR SMITH BADLY INJURED *

A very serious accident occurred sometime last night as a result of which Arthur Smith was terribly injured, while at work in the bake shop. He had been in Peterboro attending the ball game and as it. was quite late when he returned he went right to the shop. No one knows how long he had been there when the accident occurred, but apparently he had gone to shut off the engine when in some way his clothing was caught in the shaft holding the flywheel and he was whirled around striking his head and shoulders and other parts of his body. His head was smashed and torn in several places, the wounds being very severe.

The accident was discovered about 50'clock by his son, Gerald. Sometimes, after mixing the bread Mr. Smith would sleep at the shop until it was ready to work, so that it was not unusual for him to be very late returning to his home. About 5 o'clock Mrs. Smith became so worried that she sent Gerald to the shop and he found his father lying by the engine in an unconscious condition. He quickly summoned help and both Drs. Crawford and Thomson did all they could to aid the injured man. An ambulance was summoned and he was taken to Belleville hospital shortly after 7 o'clock.

ACCIDENT PROVED FATAL *

Since writing the foregoing word has been received that Mr. Smith passed away in Belleville hospital without recovering consciousness. While an inquest will likely be held it is doubtful if it will ever be known just how the accident occurred. The deceased has resided in Marmora for about twenty-five years and had a great many friends. He is survived by his wife, formerly Miss Clara Boyd, and two sons, Gerald and Roy. He was a member of the Orange Lodge and the Black Nights.

A verdict of accidental death was returned at adjourned inquest last Thursday by the jury empanelled to enquire Into the death of Arthur Smith, of Marmora, who was found on the floor of the bake shop owned by C. A. Lummis in an unconscious condition on October 6th. The man afterwards passed away in the Belleville General Hospital. The jury stated in their verdict that they presumed the man fell on the engine, while he was mixing his dough for the next day's business.

Dr. Boyce, coroner, presided at the Inquest and B. C. Donnan was present for the Crown when the adjourned hearing took place last Thursday evening at the police station. It will be remembered that the Crown Attorney was not satisfied with the answers to some of the questions asked at the first hearing and requested of the court an adjournment, until the officers could investigate the surroundings and give some opinion as to the man's demise.

Sergt. Clark and Constable McCoy both gave evidence to the effect that the shirt sleeve of the deceased was wound quite tightly around the governors of the gasoline engine and that the switch was on and all the gasoline in the tank had been emptied signifying that the engine ran some considerable time after the accident. The clothes worn by Smith at the time were produced in court and bore ample evidence.

The officers also stated that dough was found on his boots to show that he had been working sometime before the accident happened.

Charles Shannon gave evidence to the effect that he saw Smith shortly after midnight and that he was placing water in the mixer preparatory to prepare the bread for the next day. He was in good health and perfectly sober, said witness. William Sanderson told of being with deceased that afternoon at the ball game In Peterboro and when arriving In Marmora, Mr. Smith went directly to the bake shop and started work as he was later than usual.

Charles Lummiss concluded his evidence which was started at the first inquest but nothing new was brought to light. The son, Gerald Smith, told again the story of finding his father and the reason why he went to the shop.

She is survived by one son, Roy, of Marmora, and one daughter, Mrs. Norman Leal, of Windsor. Her only brother, S. Casha Boyd, passed away a few years ago.

The funeral service was held on Saturday from the residence of her son, McGill street. Service was conducted in St. Paul's Anglican Church by Canon J. GERALD SMITH FATALLY INJURED *

Sometime during the early hours of Sunday morning Hugh Gerald Smith met with a fatal accident while In charge of the compressor which supplied air power to the Pearce mine just east of Deloro Smelting & Refining Company's plant. As he was alone at the time it will never be known just how the accident occurred, but apparently he was caught in the belt in some way. The compressor was operated by electric power and the duties of the man in charge were chiefly to keep the machine oiled and turn off the switches in case the power was shut off or the motor stopped for any reason. As the compressor was still running when the body was discovered about 6 o'clock Sunday morning the man in charge of the pumps at the mine, a short distance away, did not suspect anything was wrong.

The body of ""Jerry" Smith was found lying face down on the floor of the compressor room by William Goodchild, an employee of Deloro Smelting & Refining Co. Limited. The left arm was torn off between the elbow and shoulder, the chest crushed in and ribs broken and other serious wounds on head and body. Life had been extinct for some time and it is thought death twas almost instantaneous.

Dr. S. Eagleson, coroner, of Madoc, was notified and investigations were carried on by Provincial Officer A. Kidd, of Madoc, County Constable Percy Gray and Village Constable George O'Neill, of Deloro. A jury was empanelled composed of Geo. Dennis (foreman), Clare Naylor, Frank Leal, John Cross, Orville Trumble, Bert McCann and Alex. McFaul. After consultation with Crown Attorney B. C. Donnan, K.C., the time of the inquest was fixed for Friday, June 26th, at 2.00 p.m. A post mortem examination was conducted by Dr. Reginald Taft. Dr. H. Crawford was also called to the scene of the accident.

The late Gerald Smith was born In Marmora on July 1st, 1908, and had been a resident of Marmora all his life. He was a son of the late Arthur Smith and Mrs. A. Smith. After leaving school he entered the employ of the late Hugh Wiggins as clerk in the grocery store. He held the position for several years, first with Mr. Wiggins, then with C. A. Lummiss and then with Lummiss and Bonter, the ownership of the business changing twice.

He was considered one of the most efficient and popular clerks ever to work in the village. He gave up the work to take a position with an insurance firm, but the depression spoiled his chances and he had since been unable to secure any permanent employment. He had always been popular, especially with the young men amongst whom he had grown up.

On August 12, 1930, he was married to Margaret Bailey, daughter of James E. and the late Mrs. Bailey, who survives him with three young children, two sons and a daughter—Ronald, Douglas and Margaret Ann. He is also survived by his mother, one brother, Roy, and one sister, Mrs. Korman Leal, of Windsor.

Arthur Smith, father of the deceased, met with a tragic death on October 6th, 1927, as a result of injuries received when his clothing caught in the shaft of a gasoline engine in Lummiss & Bonter's bake shop.

The funeral was held on Tuesday afternoon proceeding from his mother's residence on Burstall street. Service was conducted by Rural Dean A. B. Caldwell, who preached an impressive

sermon from the text "If a man die shall he live again". He emphasized the fact of immortality and the future life as one of activity and achievement, without the handicaps, suffering and sorrows of this life. A very large number attended the funeral as an evidence of sympathy with the bereaved relatives. Interment took place in Marmora Protestant Cemetery. The pall bearers were Messrs. Ralph Neal, Carl McCoy, Gordon McWllliams, Eugene Brady, Frank Grant and Joe Murray.

GERALD SMITH * Death Was Accidental - Verdict Blames No One

The inquest in connection with the death of Gerald Smith, who was found dead in the compressor room of the Centaur mine at Deloro on Sunday morning, June 21st, was held in Deloro hall last Friday afternoon. The Coroner was Dr. S. Eagleson and Crown Attorney B. C. Donnan, K.C., examined the witnesses. Mines Inspector. T. Webster, of Toronto, was also present.

The following composed the jury: G. Dennis (foreman), O.Trumble, J. Cross, B. McCann, F Leal, C. Nayler and A. McFaul.

Dr. Reginald Taft, who performed the post mortem, was the first witness and he described the injuries suffered by the deceased. They included a bruise on the temple, a burn on the side of the face, breast bone crushed, several ribs broken, collar bone dislocated, left arm severed and lacerations on the left side. The injuries were such as might have been caused by being caught in the belt and were sufficient to cause death.

W. Phelan, mining contractor, who had the contract to sink the shaft at the Pearce mine for the Centaur Co., gave evidence as to the operations being carried on. About 18 men were employed and they were covered by Workmen's Compensation The equipment had all been inspected and was in perfect condition. Gerald Smith was believed to have operated the same kind of a compressor for the Standard Paving Co'y. He worked alone on the night shift.

W. Leonard, engineer in charge, testified he saw Gerald Smith in Marmora the evening before the accident and he appeared to be in normal condition. The motor and compressor were operating in perfect condition when the body was found except that two hooks on the belt were broken and hanging down.

Gerald Potts, who was operating the pump, saw the deceased about 1 45 a.m. Didn't know how the accident could have happened unless the victim was feeling the motor to see if it was heating. Provincial Constable Alex Kidd told of being called at 6.30 a.m. and .of going to scene of accident where he met County Constable Percy Gray. He described conditions as he found them in detail. He told of the hooks still on the belt and hanging down and of finding blood stains on brick wall and ceiling. He also found hairs on the motor and blood in a groove on it. Frank Grant, Roy Wright and E. Bradley, employees in the metals dept. of Deloro Smelting & Refining Co. Ltd., told of deceased coming to plant for a few minutes about 2.30 a.m. and was in normal condition.

Harold Price worked one of the shifts of the compressor. He described duties and said there was a guard between east entrance and machinery. They used to go under guard to feel bearings but were supposed to go around and enter by west door. Had instructions to shut down compressor before filling oil cups.

William Goodchild, stationary engineer, told of finding the body after the accident and of notifying various officials, etc.

After hearing all the evidence the jury brought in a verdict of accidental death and no blame was attached to anyone.

WM. SMITH SHOT HIMSELF. *

A shocking tragedy occurred last evening when William Smith, son of Mr. Harry Smith, of Deloro, shot himself. At about 11.15, the time the shooting took place, the deceased was in the rear seat of a Ford Coach, driven by his brother, Simeon. Gordon Stewart was in the front seat with the driver and they had started toward Deloro. The car stalled on the intersection of Burstall and Matthew streets and then the shot rang out. Constable Percy Gray and Mr. E.C. Prentice were in the Post Office at the time and rushed to the scene of the tragedy. The victim was still breathing when they reached the car and he was rushed to Dr. Crawford's office, but passed away before reaching that place. A 44-40 rifle was used and the bullet entered Smith's heart and came out through his back.

Various rumors are in circulation as to the reason for the rash act, but apparently the deceased had spoken of ending his life a number of times in the past few days, but was not taken seriously by his companions. His brother and Stewart claim they took the gun from him once last evening, but even then they did not know it was loaded or think he really intended to use it. He had been working for Deloro S.&R. Co Ltd.

Provincial Officer J. Kelly, of Belleville, and Dr. Eagleson, Coroner, of Madoc, were called. After learning the particulars as far as possible it was decided no inquest was necessary. When the gun was examined by Constable Gray it was found to only contain the one empty shell and there were no shells in the magazine.

The deceased had been popular with a large number of young friends. The funeral will leave the residence of his father, Mr. Harry Smith, Deloro, at 1 30 p.m. on Saturday, Nov. 3rd and proceed to St. Paul's church, Marmora, for service, after which interment will take place in Marmora Protestant cemetery.

WILLIAM SMITH INQUEST *

The Inquest in connection with the death of the late William Smith, of Deloro, was held in the Council Chamber last Friday afternoon with Coroner Dr. Eagleson, of Madoc, presiding. B. C. Donnan, K. C., County Crown Attorney, conducted the examination of witnesses and an official stenographer kept a record of the proceedings. Reporters were present from the Toronto Daily Star and the Belleville Ontario Intelligencer and also an officer of the Provincial Police force, as well as County Constable Percy Gray, who had summoned the various witnesses. The setting was complete for a sensational inquest, but no new evidence or anything of a startling nature was brought out. Eleven witnesses were called and their combined evidence gave a pretty full account of the actions of the deceased on the day of the tragedy. Harold Nobes told of working on the night shift with Smith at Deloro on the night previous and of waiting until the deceased was ready to come to Marmora about 9 o'clock in the morning. Later they went back to Shannick returning during the afternoon. Nobes also saw Smith in the evening and he appeared quite normal on all occasions. Miss Jean Fenn gave evidence of a friendship with the deceased over a period of about a year, going with him to dances and other affairs, etc. She told of him calling for her about 7 o'clock on Hallowe'en, when she informed him she had made plans to go out with Marmora friends in costume during the evening. She related how the deceased had followed her from place to place during the evening and how he gradually showed the effects of drinking and finally showed her a rifle and told her "You're going to get it." Other witnesses were Constable Percy Gray, Dr. H. Crawford, Miss Iva Phillips and Messrs. Clifford Spry, Edward Warren, Ralph Campion, Simeon Smith, Gordon Stewart and E. C. Prentice. The Coroner, after the close of the inquest, remarked on the candid and straightforward manner in which the witnesses gave their evidence so that there was no suspicion of any material evidence being withheld. The evidence of Simeon Smith, brother of the deceased, was particularly helpful to the jury in arriving at their verdict. He gave a full outline of both his own actions and those of his brother, as far as he knew them, during the evening and just preceding the shooting. When the witness and Gordon Stewart, entered the car William Smith was at the wheel. They stopped near Ralph Campion and Jean Fenn and the deceased first talked to the latter and when Campion attempted to reason with him, Smith struck at Campion and knocked his hat off. The witness told the latter to beat it. Simeon also told of his brother drinking two bottles of beer and throwing the bottles out of the car.. He then said for "some one to drive this crate" and got into the backseat. The first time he threatened to use the gun, Simeon took it from him. The car stalled on the corner of Matthew and Burstall streets and when witness turned around his brother was leaning back with the butt of the rifle against the back of the front seat and the muzzle against his breast. The former grabbed the gun by the stalk and the barrel and attempted to get it away when it was discharged, the bullet entering William Smith's body just over the heart and coming through his back to the right of the spine. The bullet also went through the rear window of the car and was not found. Constable Gray and Mr. E. C. Prentice gave evidence of reaching the car just after the shooting and described the position of the body and other details. Mr. Gray also produced the gun, the empty shell, and unused shell taken from the pocket of the victim, the two beer bottles which had been thrown from the car and other exhibits. Dr. Crawford gave brief evidence as to the apparent cause of death, etc. Following the evidence the jury brought in a verdict that the deceased came to his death as the result of a gunshot wound delivered by an act of his own hand. The funeral service was held last Thursday afternoon service being conducted in St. Paul's church by Canon J. M. Brownlie, who gave an impressive address. The hymns sung were 'Jesus Lover of My Soul' and Abide with Me". Interment followed in the new Orange plot in Marmora Protestant cemetery. The service was under the auspices of Marmora L.O.L. No. 319. . Last rites of the Order were conducted by W. M. Cecil Holland and Chaplain W. J. Cottrell. There were many beautiful floral tributes.

The pall bearers were Herbert Wright, Fred Matthews, Stewart Varty, Percy Gordon, Gordon Jones and Clayton Clemenger, all members of Marmora L.O.L.
