Corporal Hatch also described a visit to Watkins General Store three miles east of Norwood on No. 7 highway where Mr. and Mrs. Charles Head had taken Toms after returning Boyd to his home following their visit to the Ellis home. Boyd's Liquor permit and wallet were handed over to Corporal Hatch by Harry Boyd, brother of the deceased and Harold Russell.

HAD PRUCHASED LIQUOR

The permit showed that on March 1st, Boyd had purchased three 12 ounce and three 26 ounce bottles of liquor at the Marmora liquor store. An examination of the wallet showed it contained \$36.62. Having finished his account of his investigations the officer mentioned that he had encountered many rumors which could not be substantiated.

Dr. Ward Smith, analyst, asked to give his qualifications to the jury, mentioned having worked under Professor J. Rogers, Toronto. Samples received by him on March 13th, were found to have the following alcholic content: blood, 1.6 parts per 1000; urine 3.0 parts per 1000; spinal fluid 2.8 parts per 1000.

The only knowledge he had before making his analysis was that the samples were taken from a frozen body and cause of death unknown. The circumstances he found consistent with death due to freezing. Exposure and alcohol were two factors to explain death without bringing anything else into the picture. At the conclusion of his evidence, adjournment was made for lunch.

IDENTIFIED PURCHASE SLIPS

Major Percy Gray, assistant vendor of Marmora liquor store, identified purchase slips made out to Boyd whom he saw in the store about 11:45 a.m., 1:30 p.m., and 5 p.m., that day.

Harry Boyd, told of turning over his brother's effects to Corporal Hatch. He found the purse outside the gate and the liquor book inside. He said the home had been locked up for about 12 months during which time he had boarded with Mrs. Eddie McFall.

The home was not locked with a key. The padlock was fastened with a staple which had to be pulled to effect entrance. His brother for that same period had been staying with his aunt, Mrs. Bert Boyd. He and his brother had known Keith Toms a long while. As far as he knew Toms and his brother had had friendly relations. He had never heard either express ill will or malice towards the other. He had never seen them together much, but it could be otherwise.

TELLS OF FINDING BODY

Clarence Wallbridge testified to discovery of the body. On March 7th, deceased aunt, Mrs. Boyd, had asked him to go and see if the lock was on the door of Almond's home. He did so and saw it was all right. As he returned home a neighbour, Art Peters, came and asked if he had looked all over. So they both returned and Peters intimated that relatives were looking for Boyd. They then saw the body and reported to the police.

Arthur Peters who was next witness testified to first seeing the crook of Boyd's elbow and later the wrist as crust's of snow had been knocked off with a mitt.

Jack Hickey, local contractor, gave evidence of Boyd having been in his employ for about a year as carpenter and that he was paid every Saturday. He sometimes laid off for a while stating he had been to see Dr. H.G. Parkin of Marmora who had told him he had a heart condition.

Charles Head, next witness, related how he had been in company of Boyd on March 1st meeting him in the liquor store with Toms who had introduced him. Toms asked to drive him to Havelock and he consented. With his wife, Toms and Boyd, they started but on the way Toms asked that they accompany him to his mother's place which was assented to.

DRINKING EPISODE

He described drinking by the three men, and that to his knowlede Boyd and Toms each had a bottle of liquor. In the car was a case of beer purchased by Mrs. Head

On arrival at his mother's he found she was not at home, only his sister who did not share in the further drinking which ensued there.

Arthur Watkins related the arrival of the three at the store. He noticed the scratch on Toms hand. He did not do more than taste the drink consumed in his kitchen for he didn't like it.

Mrs. Watkins described Toms' tunic as clean and orderly but said she saw a little blood on his knuckles.

Mrs. Ellis had further evidence to add to that given in the visit to her mother's home. She said that she heard Toms say to Boyd, "Don't accuse me of trailing you, or of taking your bottle". She saw her brother hit Boyd while he was on the ground but where he was struck she did not know.

Word of the sudden passing of Donald Davidson, of Marmora, son of Mr. and Mrs. John Davidson, Tuesday afternoon came as a shock to people of Marmora and district. He had gone to Madoc to have some teeth extracted and was in the dentist's chair in Dr. Fraser's office when his death occurred. It was decided to administer gas to help him stand the shock of having his teeth extracted and Dr. S. R. Beatty was called in to give the gas. Great care was taken to help keep the amount of gas used as small as possible, but suddenly it was noticed he had stopped breathing. Two doctors were called in and every effort was made to resuscitate him but without avai1.

Donald was twenty years of age and was the youngest of a large family. Years ago he suffered with an attack of rheumatic fever and has had a heart condition ever since. He had lived nearly all his life in Marmora and had many friends. For two or three years he had been a clerk in Loveless' Groceteria, where he met many people and his friendly and cheerful disposition had made him popular with the customers. For some time he was a crucifer at St. Paul's Church and a member of the choir. For some years he was noted as a boy singer.

Besides his parents he is survived by six sisters and two brothers. They are (Dola) Mrs. George Marriott, Niagara Falls; (Margaret) Mrs. William Thompkins, Trenton; (Verna) Mrs. Cecil Neal, Marmora; (Grace) Mrs. James McMurray, Marmora; (Myrtle) Mrs. Clifford McCaw, Marmora; Laura at home; Clayton, Coe Hill, and Samuel, Marmora.

One sister predeceased him 43 years ago and one brother 21 years ago. The funeral is being held this afternoon, leaving his parents' residence and proceeding to St. Paul's Church where service will conducted by Canon J. M. Brownlie, Interment will take place in Fox's cemetery, Eldorado.

LOIS BEDORE DIED WHILE SWIMMING IN CROWE RIVER.

A tragedy occured Sunday evening when Lois Faye Bedore, youngest daughter of Mrs. Wilbert Bedore and the late Mr. Bedore, passed away while swimming. She was an expert swimmer and enjoyed the pastime. She was in the water alone at the time, at the bathing beach just below the bridge over No. 14 Highway and no other swimmers were around at the time, It is reported one or two people saw her in the water, but knowing how well whe could swim did not pay any attention.

No one knows when she went down but when she did not return home for supper her mother became alarmed and started out to look for her. When she could not be found a search was started. Dragging operations were started and continued throughout the night and all day Monday, except for a short time in the afternoon when the wind became too strong. Others searched the shores but no trace of the missing girl was found during the day.

A plane from Trenton, with a mechanical device by which it was opssible to see into the water, also joined in the search for a while about noon.

The search was resumed early Mondaa evening and about 10:30 o'clock the body was found in about ten feet of water lying on a ledge of rock near a deep hole. Several boats were close to the spot at that time. Among those around when the body was found was Jack Hickey, Josept Darrah, Lorne Gawley, Fred Harvey, Her brother Clayton and a number of others. The former two are said to have actually located the body.

September 4, 1952

The local and provincial police assisted during the day, but were not present when the body was found. They were immediately called and Coroner Dr. S. R. Beatty, of Madoc, was summoned.

For years Lois had been subject to occasional epileptic attacks. A medical examination showed that death was due to such an attack. There was no water in her lungs, which was evidence death was not due to drowning. The Coroner decided no inquest was necessary.

The deceased was 19 years and 3 weeks old. She had a good record as a student in the public school and Marmora high school. She also attended Madoc high school for a short time. She was a member of St. Andrew's United Church and for a few years was a member of the junior choir, occasionally taking a solo part.

Her mother, Mrs. Bedore, has the sympathy of the community in bereavement. About six months ago she lost both her husband and father within a few hours of each other.

Besides her mother she is survived by one sister, Mrs. Cliff Goodchild (Doris), Marmora township, and three brothers, Clayton, Marmora; Eric, Havelock; and Thomas, at home. She is also survived by three grandparents, Mr. and Mrs. Julian Bedore and Mrs. Thos. E. Potts, all of Marmora.

The funeral was held yesterday afternoon from her late residence to St. Andrew's United Church, where service was conducted by Rev. K.J. Crawford. Interment was made in Marmora Protestant Cemetery.

RAYMOND NOBES WAS KILLED IN MOTOR ACCIDENT SUNDAY

A tragic motor accident about 5:30 Sunday morning resulted in the death of Raymond Nobes and serious injury to William Cain, of Deloro, owner of the car involved. The two had been around together during the afternoon and evening, but where they spent the night or where they were going so early in the morning apparently is not known.

The car must have been travelling at a terrific speed as tire marks indicate it left the pavement on the right side of the road and when it was swung back on the pavement it turned nearly around and skided sideways across the road and into the ditch where it hit a pole and bounced into the air going over a clump of bushes about ten feet high without breaking the tops of any of them. As the car went into the air the front door flew open and Cain and the seat were hurled over twenty feet, landing some distance apart. Apparently as Cain came down he landed in some bushes, which partially broke his fall. The top of some of the bushes were broken off near where Cain was lying.

As the car turned over it appears as though Nobes was thrown over the back of the front seat. When the car landed on its top, the top was crushed in until it rested almost on the two seats. The steering wheel was also bent over until it touched the seat. It is thought Raymond Nobes was killed instantly. The car was almost a complete wreck. Cain was taken to Havelock Nursing Home, where he received Medical treatment. Apparently no bones were broken, but it is reported he was later removed to a Peterborough Hospital, where he could be given a complete examination.

Raymond Nobes was a son of Mrs. May Nobes, of Marmora, and the late James Nobes. He was thirty-five years of age last June and was born in Marmora township, but had lived nearly all his life in Marmora village. He served overseas during the second world war with the Hastings and Prince Edward Regiment and won distinction as an expert rifle shot and sniper and for his coolness under fire.

Besides his mother he is survived by three brothers, Harold and Arthur of Marmora, and Everett, of Toronto. He was unmarried.

The funeral was held on Tuesday afternoon under the auspices of Marmora Branch No. 237 Canadian Legion, with about fifty ex-service men in attendance. The cortege left his late residence for service at Marmora Free Methodist Church at 4 p.m. This was conducted by the Rev. G.H. Bache, pastor of the church with the Rev. A.B. Moffatt, district superintendent, Assisting. The latter offered prayer and read passages of Scripture while Rev. Bache preached on words to be found in the 8th chapter of the book of Jeremiah, 'What have I done?' One hymn "Rock of Ages" was sung.

Burial took place in Beaver Creek Free Methodist cemetery. The honorary pall bearers were past and present members of the Hastings and Prince Edward Regiment, in which the deceased member served in the Second World War, namely; Lieut. Angus Duffy (who was Nobes' sergeant major), Sergt. Major Tom Ash, O.C.; William Nayler, Sergt. James Winfield, Captain Percy Gray and Private W. Jowett, R.C.A.S.C. (active force.)

The active pall bearers were: Tom O'Brien, George Bateman, Clinton Nickle, Edward Warren, Robert Gray and Marshall Sopha.

At the cemetery committal sentences were read by Rev. A.B. Moffat. Last rites of the Canadian Legion were taken by the chaplain, W. J. Cottrell. Last Post and Reveille were sounded by First Lieut. Armand Duffy, Belleville.

Visiting Legionnaires were present from Belleville, Trenton, Carrying Place and Bancroft branches. Past President, Clayton Bedore was in charge of the parade.

CHILD INSTANTLY KILLED

Ross Everett Tandy, 15 months old son of Mr. and Mrs. Ross Tandy, was instantly killed on Tuesday afternoon when struck by a car on No. 14 highway in front of his parents home, about a mile and a half south of the village.

According to reports the child was struck by a car driven by Gordon Victor Thomson, 96 Wragge Street, Trenton. The little child was following his brother, aged 5, and ran in front of the car. The body was rolled about 60 feet in front of the car.

Provincial Police at Madoc were notified and Cpl. Jack Hatch and Constable R. Devey investigated. Coroner Dr. R.S. Beatty, of Madoc, was notified and he ordered an inquest. A Preliminary inquest was held Tuesday afternoon and adjourned until Tuesday, October 6th.

October 8, 1953

CHILD KILLED NEAR MADOC

Ivy Lynn Rump, two years, 11 months was killed Sunday morning when a car driven by her uncle, 15 year old Halsey Wiggins backed over her outside his home on highway 7, about seven miles east of the village.

The child apparently was playing behind the parked car in the yard of the Wiggins' home, unknown to the youth. Wiggins was turning round in the yard for the family to drive to church.

Police said her father, Robert Rump, is in hospital in Cornwall. With her mother she had been staying in Madoc township for the past six months and had been visiting her grandparents, Mr. and Mrs. F. Wiggins. They had previously stayed in Belleville.

A preliminary inquest was held yesterday by Dr. S.R. Beatty, Madoc, but was moved to a future date.

The deceased was born in Belleville where she lived until the family moved to Madoc township six months ago.

Surviving in addition to the parents, is a brother, Richard and grandparents, Mr. and Mrs. F. Wiggins, Madoc township.

The funeral service was held at the home of her grandparents in Madoc township on Tuesday afternoon with burial in Marmora Protestant cemetery.

OVERCOME WITH CHOKING

Mrs. Clara Boyd, beloved wife of Albert (Bert) Boyd, died suddenly at her home west of the village on Monday morning. Overcome with a choking sensation she had asked her husband to bring her a glass of water, but she passed away before he could return with it.

She was in her 67th year and was born in Seymour Township, the daughter of the late Mr. and Mrs. George Riley.

Of a quiet friendly nature she was held in high respect by her neighbors and all who knew her. She is survived by her husband.

The funeral service was conducted at the Wells' Funeral Home at 1:30 p.m. on Wednesday by Rev. K.J. Crawford, pastor of St. Andrew's United Church. Interment was in Marmora Protestant cemetery.

WM. TINSDILL DIES WHILE PICKING BERRIES

Wm. Tinsdill, aged 64, of Toronto, who with Mrs. Tinsdill (nee Bessie Sweet) had been visiting the latter's sister and brother here for the past few days was stricken suddenly while picking huckleberries yesterday afternoon.

He and Mr. E. C. Prentice, Village Clerk, had gone out picking berries on the rocks north of Davidson's Garage about five miles east of Marmora yesterday morning. Shortly after noon they lost their way and wandered about until nearly 5 p.m. before they came out near the highway.

Wishing to fill their baskets they began picking again and became separated and when Mr. Prentice got out to the road, Mr. Tinsdill had not showed up. Mr. Prentice called to him and receiving no answer looked for him for some time then came into Marmora and organized a search party.

Mr. Tinsdill body was not found until noon to-day and it appeared that he had suffered a heart attack and slumped down on the ground and that death had come very suddenly.

The late "Bill" Tinsdill had made many friends in Marmora since his marriage and had spent all of his vacations here. He was a resident of Toronto.

MARMORA CHILD KILLED BY CAR

A tragic accident ocurred early last evening when Brian Uniach, 12 year old son of Mr. and Mrs. Edward Uniach was struck down by a car and instantly killed.

The accident occurred on No. 7 highway just opposite the garage operated by Carl Simpson. The boy, who was a carrier for the Daily Star, was delivering his papers at the time. While he had ridden a bicycle to that point it is thought he was walking when struck.

The driver of the car which struck him was William Mackenzie of R.R. 3, Oshawa who was proceeding east at the time. He stated that he was meeting some west bound traffic at the time and was blinded momentarily by the bright headlights of an approaching vehicle. He did not see the boy until the accident occurred. Another driver who was following him also stated that the lights on the west bound vehicle were on the high beam and very bright.

The deceased was the youngest son of Mr. and Mrs. Uniach and is survived by two brothers and two sisters as well as his sorrowing parents. Mr. Uniach is a salesman for the White Hardware Co. of Toronto and was in Barry's Bay at the time of the accident. The family had moved to Marmora from Stirling during the past year and had made quite a number of friends in the community.

The sympathy of the entire village is extended to the bereaved family.

The accident was investigated by Prov. Constable Devies of the Madoc Detachment and an inquest will be held in Marmora Town Hall on Wednesday, December 14th.

December 8, 1955

TRUCK TRAIN CRASH AT BONARLAW TAKES TWO LIVES

One of the most tragic accidents in the history of this area occurred about 8:30 a.m. on Saturday December 31st, when a light truck driven by Smith Fraser of Rawdon township skidded into the path of a C.N.R. train at the 12th line crossing. Maxine Fraser, aged 10 was instantly killed, Smith Fraser was fatally injured and Carol Fraser, 16, was critically injured.

Mr. Fraser was taking Carol to work at the Bonarlaw General Store and they were accompanied by Maxine. The railway track is obscured from view for some distance south of the crossing and it is impossible to see a train approaching from that direction until one is almost on the crossing. It is thought that Mr. Fraser did not see a train coming from that direction until it was too late to stop and that when he applied the brakes the truck slid on the icy road until the front end was just on the tracks.

The train was proceeding toward Marmoraton Iron Mine with a string of empty ore cars and was travelling fairly slow at the time of the accident. It dragged the truck about 40 feet up the track.

The injured victims were taken to the farm home of George Ray just west of the railway track and Dr. T.F. McCarthy of Marmora and Coroner Dr. E.A. Carleton of Stirling were both called and Bush's Ambulance removed Mr. Fraser and Carol to Belleville General Hospital.

Mr. Fraser never regained consciousness and passed away on Monday evening.

The funeral of Maxine Temple Fraser was held on Monday afternoon proceeding from her home to St. Mark's Church, Bonarlaw, where service was conducted by Canon J.M. Brownlie, Interment was in Mount Nebo cemetery.

January 2, 1956

Smith Daniel Fraser was born in Marmora 43 years ago, the son of Mrs. Ida Fraser and the late Daniel McCurdy Fraser. He had lived in this area all his life. For quite a number of years he was an employee of the Deloro Smelting and Refining Co. Ltd.

Following his marriage to Stella Nobes they resided on the farm just west of Bethlehem Mine on the old Madoc road. About five or six years ago they sold the farm to Ross Rogers and moved to the 12th concession of Rawdon where they have since resided.

Recently he had been employed by the Armstrong Construction Co. at their rock quarry near Marmoraton Mine.

Of a quiet and friendly disposition, Smith Fraser was a good neighbour always ready to help any one in any way he could. He was a member of St. Mark's Anglican Church, Bonarlaw and of Marmora Lodge A.F. & A.M. No 222.

He is survived by his wife, the former Stella Nobes and four daughters: Mrs. Don Leonard (Lulubelle), Marmora; Carol in Belleville hospital and Laura and Lucy at home.

The funeral is being held this (Thursday) afternoon with service in St. Mark's Church Bonarlaw.

MR. AND MRS. M. KOURI KILLED IN AUTO ACCIDENT

Citizens of Marmora and district were shocked to learn of the death of Mr. and Mrs. Michael Kouri on Monday afternoon. Mr. and Mrs. Kouri had been to Toronto and were on their way home when the accident occurred about a mile east of Peterborough.

It is not known what happened but it is thought that the wheel of the small English car driven by Mr. Kcuri had left the pavement and in an effort to pull the car back on the pavement the car went out of control and swerved across the highway into the path of a car driven by Mr. Burrill L. Payne of Norwood. Neither driver had a chance to advert the crash.

Mrs. Kouri was killed instantly and Mr. Kouri was rushed by ambulance to St. Joseph's Hospital where he passed away shortly after being admitted.

Mr. and Mrs. Kouri have been highly respected and esteemed residents of Marmora for about thirty-eight years, moving here from Tweed at that time. For quite a number of years they operated a clothing store here. After going out of the retail business Mr. Kouri was employed at various jobs around the village for some time. He then took a position as clerk in the hotel and later was employed in Peterborough and at Port Hope in that capacity, returning to Marmora a few years ago.

Mrs. Kouri made her home in Marmora and here their family of twelve children were raised. Mrs. Kouri was the former Mary Louise Zahalan and was born at Carleton Place, Ontario.

During her early life she lived in Timmins and other Northern Ontario cities before her marriage. She was of a friendly and industrious nature and took an active part in Community activities. She was a member of St. Andrew's United Church and of the Women's Association and was always ready to do more than her share in any project for the benefit of the church or aoganization. She was also a past president of Marmora Institute and her cheerful services will be missed in many ways.

Mr. Kouri was born in Syria 67 years ago, a son of a Greek Orthodox priest. He came to Canada as a youth. He was of a quiet and friendly nature and made many friends who will mourn his passing.

They leave a family of five sons and seven daughters. They are Albert, Peterborough, Joseph, with the R.C.A.F. at Camp Borden; Richard, Toronto; Bernard, Norwood; and Michael, Toronto; Mrs. Al Clarke (Louise), Mrs. J. McIsaac (Marguerite), and Mrs. Leslie Hoover (Ida) all of Toronto; Mrs. Ray Lingard (Joyce) Part Hope, Mrs. Wayne Cartmell (Josephine) South Orange, N.J. and Miss Marina (Jeannie) Kouri of the Teachers College Toronto.

Mr. Kouri has one brother, Leo, in Tweed and Mrs. Kouri has two sisters, Mrs. Annie Davids, Cochrane, and Mrs. Lillian Pickett of Toronto.

The funeral was conducted in St. Andrew's United Church yesterday afternoon and the large crowd in attendance and great profusion of flowers were a sincere tribute to the memories of the deceased couple.

The service was of a special nature with Rev. K.J. Crawford conducting the usual service of the United Church and Rev. Gregory Abboud, rector of St. George's Syrian Orthodox Church, Toronto and three or four members of his congregation conducting the Greek Orthodox funeral service.

as a result of injuries received late
yesterday afternoon. Gary was sliding
on the road at the north end of Camp

on the road, brought the truck to a stop.

Icy road conditions kept the vehicle moving, however, and the young child's toboggan collided with the truck. The youngster received injuries to his body, concussion and shock. No blame has been attached to the driver.

Jim was a student at Queen's University and was on his way home after a class dinner on Friday evening. He was driving a car which went out of control and rammed a tree on a boulevard on Ellerbeck street. He was accompanied by a fellow student John David Forbes of Fredericton N. B. who was taken to Kingston General Hospital and is reported to be in good condition. The car was a complete wreck.

Jimmie Hickey as he was popularly known was born in Marmora and was a son of Mr. James Warren Hickey and the former Mary Watson. Mr. Hickey has been post master in Marmora for many years and Mrs. Hickey is assistant post master. Jimmie was 23 years of age.

He attended public and high school in Marmora completing his high school work in Madoc and has been studying mechanical engineering at Queen's University for the past four years. He would have graduated next month and had accepted a position with the Ontario Hydro.

In addition to his parents he is survived by two sisters, Mrs. Thomas Lewis (Isobel) of Detroit and Miss Phyllis Hickey, at home. He was a member of St. Paul's Anglican Church.

The funeral was held on Monday afternoon from the Howden Funeral Home, Marmora, to St. Paul's Anglican Church where service was conducted by Rev. R. G. Fleming, the rector of the church, assisted by A. N. Laferty, Chaplain at Queen's University.

March 27, 1958
